Abby-

Pursuant to the current Road Maintenance Agreement ("RMA") with the City of Aurora ("COA"), we currently have rights on Yale Ave. to the Eastern section line of section 26, 4S-65W. We have been working diligently with the COA to amend the current RMA for the past 8-12 months to reflect needed revisions due to COA annexations that have occurred adding portions of Yale Ave., Jewell Ave., and other former Arapahoe County roads. The feedback we received from COA during this time period was that the RMA would not be amended until the Aurora "Oil and Gas Operators Agreement" was executed. The Oil and Gas Operator's Agreement was executed 6/5/19 by both parties, and the COA has assured ConocoPhillips Company that they are currently reviewing the amended RMA. ConocoPhillips Company will provide the COGCC a copy of this agreement immediately following its execution by COA.
