The Bost Farm 26C-8-L well was drilled within it's originally approved unit setbacks, but was completed short of the orginally approved wellbore spacing unit due to formation stratigraphy. This sundry has been submitted to reduce the GWA spacing unit by approximately one qtr/qtr, removing the SESE qtr of Sec 1, T5N, 67W.

The new proposed spacing unit description is as follows:
T5N-R66W Sec5: S/2S/2; Sec6: S/2S/2; Sec7: N/2N/2; Sec8: N/2N/2
T5N-R67W Sec12: NE/4NE/4
