2. Unsuitable - Irrigation well Permit # 15027-K could not be located. Land has been subdivided.
3. Refuse to grant access - Irrigation Pond Annex #8. No response from owner, WRCC. No permit number (surface water).
4. Unable to locate well -Permit # 34315, issued 1968. Land has since been subdivided. Sent letters to the new owners of subdivided parcel. No response.
5. Collected sample from Leatherman, Permit #13275-R, Reception # 9038908. The original well location property was subdivided. The Operator sent letters to all current owners and only Leatherman responded.
6. Therefore, there is a total of one water well sampled and three exceptions requested. Please see attached documentation of letters sent.
