This inspection is a follow-up inspection to #696200360 dated 7/8/2019, and #696200564 dated 8/08/2019 to document compliance for the following corrective actions:

603.f: Noxious weed management

During this inspection, it was observed that the Operator has failed to conduct sufficient noxious weed management in an appropriate time frame to prevent seed dispersal from mature plants, and the possible spread of Canada Thistle along the access road and adjacent lands.

Comment:	<p>Inspection #696200360 and #696200564 documented noxious weeds (Canada thistle) establishing along the access road and required Operator to comply with 603.f and conduct noxious weed management.</p> <p>Previous inspections documented that noxious weeds were maturing and will soon disperse their seed.</p> <p>It was observed in this inspection that Canada thistle has reached maturity, and the majority of the plants have dispersed their seed.</p> <p>Operator has failed to conduct noxious weed management in an appropriate time frame, to prevent seed dispersal from mature plants and the possible spread of Canada Thistle onto adjacent lands.</p>
