 On 08-21-2019, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Sound. The complainant William H Kelsey 2201 Indian Paintbrush Way Erie CO stated the issues were occurring outside of complainants home. On 08-21-2019, I attempted to make contact with the complainant who indicated that on 8-20-19 on a regular basis there is enough "Construction/drilling" type noise to hear loud and clear and it makes it hard to sleep. I hear the noise throughout the day sometimes but the bothersome time is between 11PM and 2AM. This has been on going for at least the last several weeks.
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not observe any unusual sounds. Please refer to attached 3rd party sound study information from 7:00PM to 7:00AM in complaint inspection report.
 At time of inspection, I spoke with frac supervisor he stated at time of complaint they were fracing and no unusual activity was taking place.
