 Field Inspector Actions:
 On 08-21-2019, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Smoke. The complainant Christie Stanford 2778 Trinity Loop Erie CO stated the issues were occurring outside of complainants home.
 On 08-21-2019, I attempted to make contact with the complainant who indicated that on 8-20-19 for the past several day seeing a black plume of smoke coming from the site for the entire day.
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did observe what appeared to be emissions coming from the frac pump trucks. COGCC does not regulate emissions. This well is located next to a active landfill, there are several pieces of heavy equipment creating emissions working on landfill around well site.
 At time of inspection, I spoke with frac supervisor he stated at time of complaint they were fracing and no unusual activity was taking place.
 Weather conditions: Clear and location was dry
