OPERATOR COMMENTS AND SUBMITTAL

Comments

- While drilling the 8-3/4" vertical-curve section of the well we were unable to achieve sufficient build-rates to land the wellbore at the planned TVD. After tripping out of the hole and running back in with a larger bend motor, we were still unable to achieve the necessary build rates. As a result, we made the decision to plug back and sidetrack above the planned KOP in order to land the well at the appropriate depth.
- The total measured depth of the wellbore which we are abandoning is 7832' MD.
- The 9-5/8" surface casing string is set at 1621' MD
- There is no fish in the hole.
- There will be a 500' cement plug pumped from 7500' - 7000' MD.
- The Sidetrack KOP will be 7000' MD.
- The objective formation for the sidetrack hole is the Codell formation, which is the same objective formation as the wellbore being abandoned.
- The PBHL of the sidetrack hole is the same as the wellbore being abandoned.
- This well has a bottom-hole location beyond the unit boundary setback. The bottom of the completed interval will be within the unit boundary setback at 300' FSL and 1809' FWL of Section 4. The wellbore beyond the unit boundary setback will be physically isolated and will not be completed.
