SRC completed final reclamation at the well head 7/27/2017. SRC recontoured, added topsoil for proper elevations, deep ripped, and disked. Well is in flood irrigated farm ground so proper grading was achieved to ensure drainage of irrigation. The well and related facility are in the second growing season and appear have achieved comparable growth compared to reference areas around the well and access roads. Pictures are attached.

The facility is shared with the Reeman 12-5 well, but they have different location ID numbers. The Reeman 12-5 locaiton ID is 306217 and was closed 1-1-2018. The Reeman 12-5 well producted into the same facility as the Reeman 11-5 locaiton ID # is 306265.
