A lease operator identified a leak on the P27 location after the wells were shut in and during AVO inspections. The pipeline was reported to have a pin hole releasing gas and liquid. The location has been sampled to determine if additional remediation will be required. excavated soils have been removed via a hydrovac and brought to the North Solids Facility and soils removed with the excavator have been stockpiled adjacent to the point of release.

**OPERATOR COMMENTS:**

Based on the attached Report of Work Completed (ROWC) prepared by Entrada Consulting Group, Caerus is requesting that a "No Further Action" designation be given to this spill/release project. Based on analytical data, all impacted soil (approximately 10 cubic yards) was removed and samples collected from soils adjacent to the impacted area comply with COGCC Table 910-1 Concentration Levels or were within background concentrations for arsenic except those for pH and SAR. In order to address the pH and SAR exceedances exhibited in the cuttings, Caerus is requesting consideration for COGCC Table 910-1 Concentration Levels for pH and SAR under guidelines set forth under FAQ 32 as all samples were collected from soil a minimum of three feet beneath the ground surface. Caerus believes the request for FAQ 32 consideration is acceptable as there are minimal potential receptors in the area and environmental impacts to these receptors are unlikely. The entire pad surface is contained by a perimeter berm to reduce the chance for overland flow from exiting the pad surface. The nearest downgradient surface water is 300 feet to the west and groundwater at the site is estimated to be approximately 50 feet below the pad surface based on topography. Additional project details including detailed analytical results, sample locations, and excavation area can be found on the attached ROWC and analytical reports.
