Operator Comment: Stuffing box rubbers were the cause of the leak of oil onto the wellhead. On Friday, August 16th, our lease operator replaced these rubbers and cleaned up the soil near the wellhead. Stuffing box rubbers can be variable in how long they will function before requiring replacement. We plan on replacing these on a quarterly basis going forward - if we find that this time is too long, we will adjust accordingly.
