While there, I observed Production well site. During this inspection the following possible compliance issues were observed: Mechanical issue: Rule 605 d Corrective action date of 9-26-19 See photo 2 Trash: Rule 603 f Corrective action date of 9-9-19 See photo 2 This is inspection due to a new complaint. At time of inspection Pumping jack is not able to operate due to PU belts appear to be torn off and laying on ground. I spoke with complainant/landowners, Brittney White and Julie Hladky who stated gates to the entrance to the well site had been left open and their horses got out into open pasture. A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
