Unused tubing, and pump jack pieces, are stored on the well pad." SG responded on 1/19/2018 via email to a similar CA. It is important for COGCC to understand that this CA to

Operator Comment: remove the pump jack and its associated equipment has been discussed several times with COGCC staff and the end result was a suggestion from Margaret Ash on 11/17/17 to submit a Sundry requesting delay of the CA. That day, on 11/17/17, SG submitted a sundry (401463307), and followed up with an email to several COGCC staff members stating a sundry was submitted. This sundry and emails are available to COGCC upon request if it cannot be found in your database. Why is COGCC not addressing this variance request, and continuing to give more corrective actions? SG has done our due-diligence in trying to stay in compliance. This is a wildcat field that needs to have COGCC respond to requests that do not fit within the rules for other operations. The requested timeframe to fix the CA has passed, SG needs to extend that request, however it appears there isn't a reasonable approach to take for this extension request.
