<p align="center"><b>ORDER GRANTING UNOPPOSED MOTION TO ALLOW TRANSFER OF OPERATORSHIP OF CERTAIN WELLS, REMOVAL OF CERTAIN WELLS FROM RECEIVERSHIP, AND REQUEST FOR STATUS CONFERENCE</b></p>		

THE COURT, having reviewed the Unopposed Motion to Allow Transfer of Operatorship of Certain Wells, Removal of Certain Wells from Receivership, and Request for Status Conference (“Motion”), and being otherwise fully advised in the premises, hereby GRANTS the Motion.

1. The Behrens 100% Wells and the 50/50 Wells, as identified in the Motion, are hereby RELEASED from the receivership imposed by this Court and all associated orders.

2. Within fourteen (14) days of this Order, Overland Resources, LLC, on one hand, and Plaintiff, on the other, shall execute all documents required by the Colorado Oil and Gas Conservation Commission, and any other regulatory body with jurisdiction, and take all other actions necessary to effectuate a transfer of operatorship of the Behrens 100% Wells and the 50/50 Wells (and any related facilities of such wells) from Overland Resources, LLC to Behrens Resources, Inc.

3. All issues and arguments which are not rendered moot by the granting of the Motion are preserved.
