INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A release of approximately 13.3 barrels of oil based drilling mud occurred on May 24, 2019. The initial spill was reported to the COGCC under a Form 19, Document Number 402055762, Release ID 464492. On May 31, 2019, five confirmation soil samples were collected within the spill area as shown on Figure 2. Samples were submitted for laboratory analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), total petroleum hydrocarbons (TPH)-gasoline range organics (GRO), and TPH- diesel range organics (DRO). Concentrations of TPH-GRO and TPH-DRO were added to calculate total petroleum hydrocarbons (TPH). TPH concentrations were reported above the Table 910-1 concentration levels in all samples. Concentrations of BTEX were either not detected at or above laboratory reporting limits or were reported below their Table 910-1 concentration levels in each sample. As a result of current development and completion operations at the site, the spill area is inaccessible. When the spill area becomes accessible in late summer/early fall 2019, additional soil will be removed, and follow-on confirmation samples will be collected. Sample points and the spill area were surveyed with GPS at the time of the initial sampling.

Great Western proposes to collect additional confirmation samples when the spill area becomes accessible. It is anticipated that follow-on soil sampling will be conducted in late summer/early fall 2019. Soil samples will be collected and analyzed for BTEX, TPH-GRO, and TPH-DRO based on the highest field screening measurements using a PID and visual and olfactory observations.
