A SVE pilot test was conducted on July 10, 2019. Laboratory analytical indicated SVE successfully removed VOC's from the subsurface. A plan will be developed to install additional SVE wells. A site figure will be provided on a subsequent form 27 showing the location and radius of influence of each remedial well to ensure all impacted areas are being treated with the SVE system.
