### INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Five discreet confirmation soil samples were collected (4 wall and 1 base) from the produced water tank excavation. The base and wall sample from the wall with the highest PID reading (north wall) were analyzed for benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, gasoline range organics (GRO), and diesel range organics (DRO). In addition, the base sample was analyzed for pH, Electrical Conductivity (EC), and Sodium Absorption Ratio (SAR). The results for BTEX, DRO, and naphthalene were reported below the laboratory reporting limit. The results for GRO, pH, EC, and SAR were reported within or below their respective Table 910-1 concentration levels. See the attached laboratory report, soil analytical table, and Figure 3.
