Set RBP @ 1400'. Perforate csg @ 1325'. Set a CCR @ 1100'. Pump 171 sx cmt.

Perforate csg @ 340'. Set a CCR @ 275'.

Cement squeeze perfs @ 340'. SI to allow cement to set.

Install new tbq & csg head. Drill out retainer & cement.

Pressure test lower cmt squeeze holes. Retrieve RBP @ 1400'. Run cased hole logs.

TIH w/ tbq hydrotesting to 6000 psi. Land tbq w/ SSSV.
