Response: FACTUAL REVIEW REQUEST

Basis for Review: Equipment is not owned or controlled by the operator

Operator Comment: I have reviewed the attached inspection report and offer the following comments and information for your consideration.
1. In October, 2011 Mountain Petroleum Corporation ("MPC") re-entered the subject well, tested two zones and

then abandoned those zones, and plugged and abandoned the well on 10/20/2011. No production operations were conducted by MPC and we would have had no need for power or meters. MPC had obtained the related mineral rights via an option farmout agreement with Anadarko in 2011. Murfin Drilling had drilled and abandoned the original well on 1/21/1984.

2. The location photos taken as part of MPC's permit application to re-enter the well in 2011 are attached. Note that the gate and access road, cement pads, shed, and powerlines shown in the photos you took during your 8/26/2019 inspection are also shown in the photos taken for MPC's 2011 permit. These items were clearly in place before MPC conducted any operations on this location. MPC did level and re-seed the area it disturbed after we plugged and abandoned the well.

3. The items noted in your inspection report appear to have been installed or constructed by, or at the direction of, the landowner. Note that the sign on the shed (which does not appear to be used as a meter shed) has the name "GP Minerals" and "Doris Price" on it. We believe GP Minerals is a commercial firm whose business involves municipal and industrial water; Doris Price was the landowner.

In summary, we believe Mountain Petroleum has appropriately restored the surface location impacted by its operations, and we do not have the authority or responsibility to remove the items noted in your inspection report. We ask that you issue a revised inspection report as appropriate. Please advise if you have questions or need additional information. Thank you.

COGCC Decision: **Not Approved**

COGCC Representative: Per review with Reclamation Supervisor, this factual review request is denied. Mountain Petroleum is responsible for all equipment that was installed or which was previously installed by the former operator. Mountain Petroleum was permitted the location and reentered the well and is the operator of record for the location. Mountain Petroleum will need to provide proof of equipment that is not oil and gas related. All oil and gas equipment must be removed.
