Comment:

The access road and the location have been fully recontoured and reclaimed. The perennial vegetation has uniformly established to be at least 80% cover of the reference area. Some of the vegetative species observed included Pas smi, Ley cin, Ely his, Art fri, Sti hym, Bou gra, Med sp., among other species including shrubs and trees. There were no erosion issues observed and permanent erosion controls are installed which include rock rip/rap in drainage areas, earthen berms, and vegetation. The final reclamation requirements have been completed. See attached photos
