 On 09-03-2019, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Noise. The complainant Heather Monica Korber 1559 Hickory Dr Erie CO stated the issues were occurring outside of complainants home. On 09-03-2019, I attempted to make contact with the complainant who indicated that on 9 -03-19 she woke up again to the sound of jet engines coming from the coyote pad at 5:30AM. See stated she expects a call for the Director of the COGCC.  
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not observe any unusual noise. Please see Third party noise study attached to complaint FIR. I informed complainant I would inform my supervisor Jason Gomez of her phone request.  
 At time of inspection, I spoke with fracing supervisor he stated at time of complaint they were fracing and no unusual activity was taking place.
