**General Comment:**[COGCC Inspection Report Summary.](#)

On 9-6-2019 at approximately 15:30, inspector Rick Moran, conducted a routine inspection at Sandra K Woodard well Stagner 2 and 6 in Rio Blanco county.

During this inspection the following compliance issues were observed:

- 1) Well head signs illegible. Letters are peeling off. Photos 3 & 6. Complete by 11-9-2019.
- 2) Stained & oily soil at multiple locations. Photos 8, 11, 12, 13. Complete by 10-9-2019.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.

Note: Casing open to atmosphere on wells Stagner 2 & 6. No gas odor detected at Stagner 6 for which the casing vent opening is primarily plugged with dirt. Stagner 2 filled a 3 cubic ft bag in 7 minutes and the gas odor was detected 40 ft from the well head by the inspector. No odor detected at P&A well Stagner 3. Photos 5, 9, 15.

Wells are located 800 ft from the nearest residence and 900 ft from the White River.
