 Field Inspector Actions:
 On 09-15-2019, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to dust. The complainant Susan Gornall 4480 White Rock Drive Broomfield CO stated the issues were occurring at the Livingston drilling pad.
 On 09-16-2019, I attempted to make contact with the complainant who indicated that on 9-15-19 she observed huge amounts of dust seen daily beside lighted gas and oil tower. I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not smell any dust in or around location. Location and road has recycled asphalt applied on surfaces.
 At time of inspection, I spoke with Danny Herrera drilling supervisor he stated at time of complaint they were drilling and no unusual activity was taking place. He also stated they are applying water on road and location surface daily.
