Request to flare is being made as a result of Anadarko shutting down their Third Creek Gathering System which was the gas sales outlet for the Morris 14-16. It is estimated that approximately 2/3 MCFD from the well will be flared using a central tank battery combuster. A recent gas sample tested 1/4 PPM hydrogen sulfide in the gas and has been attached.

Oil revenue dominates the economics of the well. Expansion of a new gathering system being built in the area and the sale of Anadarko assets to Oxy are possible positive developments that gas sales could be reestablished in the future.
