COMMENTS:

Request to flare is being made as a result of Anadarko shutting down their Third Creek Gathering System which was the gas sales outlet for the Miller 6-7. It is estimated that approximately 2 MCFD from the well will be flared using a central tank battery combuster. A recent gas sample tested 1/2 PPM hydrogen sulfide in the gas and has been attached.
