
This is in reply to your requests for information relative to the captioned wells.

The #1 Dressel Well was reentered to a depth of approximately 4510'. A deviation survey was conducted but the results were inconclusive. No cement or other plugs were found any place in the well and the well is now full of heavy mud with a casinghead screwed on to the surface casing, with a steel plate in the top of the head. (It is requested that we have permission to leave the well as is, pending possible future plans of re-entry for use as either a water-source well or a water-disposal well.)

The #1 Cervi-Reagan Well had 5½" production casing set on it and the well is now being completed and tested. A completion report will follow.

Thank you for your cooperation in these several matters.
