During this inspection the following possible compliance issues were observed:</p> <p>Housekeeping: Weeds growing around electric transformers. Comply with rule 603.f 10 days for weeds. CA date 9/28/2019 see photo #3.</p> <p>Housekeeping: Spotty stained soil around WH and under flow line. Comply with Rule 907.e 30 days to remove stained soil. CA date 10/18/2019. See photos #4 and 5.</p> <p>Mechanical condition: PU appears to have a leaking gasket. Comply with Rule 605.d Securely fasten all valves, pipes, and fittings to ensure good mechanical condition, inspect at regular intervals and maintain in good mechanical condition.
