 Field Inspector Actions:
 On 09-18-2019, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Noise/Odor. The complainant in Broomfield CO stated the issues were occurring outside of complainants home.
 On 09-19-2019, I attempted to make contact with the complainant who stated the noise and odor coming from the Livingston pad was terrible tonight. I was on a walk and could hear the drill rig almost a mile away. The chemical odor was overpowering and within an hour after waking by the site I had a migraine.
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not observe any unusual noise or odors. Health issues have been sent to the CDPHE.
 At time of inspection, I spoke with Drilling supervisor Danny Herrera, who stated at time of complaint they were running casing. No unusual activities were taking place on site.
 Weather conditions: Clear and location is dry
