The complainant in Jessica Love 14918 Nighthawk lane Broomfield CO stated the issues were occurring outside of complainants home. On 09-19-2019, I attempted to make contact with the complainant who stated experiencing a industrial smell in the air it stunk like gas, exhaust and like a hundred trucks rode by my house.
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not observe any unusual odors. Health issues have been referred to the CDPHE.
