Unused risers next to separators and unused equipment stored in gas meter house. COMPLY WITH RULE 603.F. (Corrective Action Date: October 18, 2019) See attached photo #6,7 in location photos.</p> <p>WEEDS AT EACH WELL HEAD. ADVISE TO REMOVE BEFORE THEY BECOME OVER GROWN. SEE ATTACHED PHOTOS.
