I, Inspector Robbie Revas, Conducted an on-site inspection at Coyote Trails 33S-20-1N and Coyote Trails 33W-15-4M Extraction Oil & Gas, at Location #319094 in Weld County Colorado.</p> <p>While there, I observed Wellsite with Drill out being performed. At the time of the inspection all night time work lights appear to be pointing downward toward work areas.</p> <p>During this inspection the no compliance issues were observed:</p> <p>Location photos are attached.</p> <p>Location is dry, weather is cloudy.</p> <p>I spoke with Travis Hillen Extraction Consultant. He explained the drill out process that was going on and the grounding procedure of the tanks being used and how the fumes were routed to the ECDs, also explained when there is need for hot work permit.
