COGCC Representative: The attached weed plan appears to provide mostly non-pertinent information regarding Wapiti's ongoing weed control plan. It is unlikely that performing weed control once annually will be sufficient. As a condition of approval of the weed control plan, Wapiti must: 1. Monitor and conduct weed control throughout the growing season. 2. Perform noxious weed control in the early Summer and Fall as recommended by the contractor. 3. Perform Integrated Weed Management such as but not limited to physical, cultural, and chemical control. Ongoing inspections will be performed to evaluate compliance of Rule 1003.f.
