## Know All Men By These Presents:

That the UNITED STATES CASUALTY COMPANY, a corporation of the State of New York, by F. M. Bullen, its Vice-President, and Conrad Wissel, its Assistant Secretary, in pursuance of authority granted by a resolution duly passed by the Board of Trustees of said Company at a meeting of that body, at which a quorum was present, held on the 27th day of January, 1949, at its office in the City of New York, State of New York, which resolution reads as follows:

And when such bonds or undertakings shall have been duly executed pursuant hereto and the corporate seal affixed, they shall be as binding upon said Company, as fully and amply, to all intents and purposes, as if they had been duly executed and acknowledged by the duly elected officers of the Company in their own proper persons. The said Company hereby reserves unto itself, however, the absolute right to revoke this Power of Attorney at any time it may desire so to do.

The said Assistant Secretary does hereby certify that the foregoing copy of resolution is a true copy of the resolution passed by the Board of Trustees of said Company at its meeting held on the 27th day of January, 1949, as aforesaid, and that said resolution is still in force.
