COMMENTS:

The method of isolation at the surface is a valve, and the well is isolated downhole due to no perforations. There is no surface pressure, the casing is currently full of water. A MIT test was performed in September 2018. The well has not been completed and produced due to low natural gas prices. A sustained NYMEX natural gas price above \$3.50/MMBTU is needed to make the completion of this well economically viable. The economic viability will be re-evaluated in one year.
