While there, I observed a shut in wellhead/tank battery location. During this inspection the following possible compliance issues were observed: 1. Weeds inside tank battery berms. COMPLY WITH RULE 603.F. (Corrective Action Date: October 4, 2019) See attached photo #5,6. 2. No BBLs labeled on H2O tank. INSTALL SIGN TO COMPLY WITH RULE 210.D.
