This sundry is being submitted to update the production facility equipment for this location. Oil Tanks-2, Buried Produced Water Vault-1, Surge Vessel-1, Blow Case-1, VOC Combustor-7, Electric Instrument Air Compressor-2. This equipment change resulted in a reduction in total disturbed area. Total disturbance will be 7.2 acres and 4.5 acres after interim reclamation. The distance to the nearest BU has increased to 1007' NE (measured to the edge of LACT area).
