	<p>There are two posts that remain at the beginning of the access road. Vegetation along the access road and location has not adequately established. There are areas where the soil is compacted which is preventing establishment. It appears soils were not properly cross ripped as there are rows of no vegetation growth and compaction. There is noxious weeds (Field bindweed) and undesirable weeds along the access road and location. There are areas of subsidence at the west and northern portion of the location. A deep hole of subsidence was measured to be 4 ft. deep which is a safety concern. Previous corrective actions have not been performed. See Attached Photos</p>	
Corrective Action:	<p>Comply with 1004 Rules. Properly decompact soils by cross ripping to a depth of 18 inches. Remove post at beginning of the access road. Fill in areas of subsidence. Should be performed immediately to prevent accident. Reseed and stabilize the soils. Control weed growth and monitor vegetation establishment.</p>	Date 11/01/2019
