Operator Comments:

Top of productive zone footages are estimated and based on the top possible legal perforation point within the unit. The estimated date of completion of the pad is 1st quarter 2020. The actual top of productive zone footages will be provided in the comments on the Form 5A when the well has been completed. The BHL footages are from the "Projection to Bit" numbers listed on the first page of the directional survey.

An open hole resistivity log was not ran on this well. Open hole resistivity logs with gamma ray ran on Golden Eagle 21C-1-M (API: 05-123-50131) & Golden Eagle 7C-1-M (API: 05-123-50122), which share the same pad.

Surface and production casing setting depths on Surface Cement Job Summary and Production Cement Job Summary are incorrect. Reported depths on casing tab, 1780' is the accurate surface csg setting depth and 15100' is the accurate production csg setting depth. 6 bbl wet shoe.
