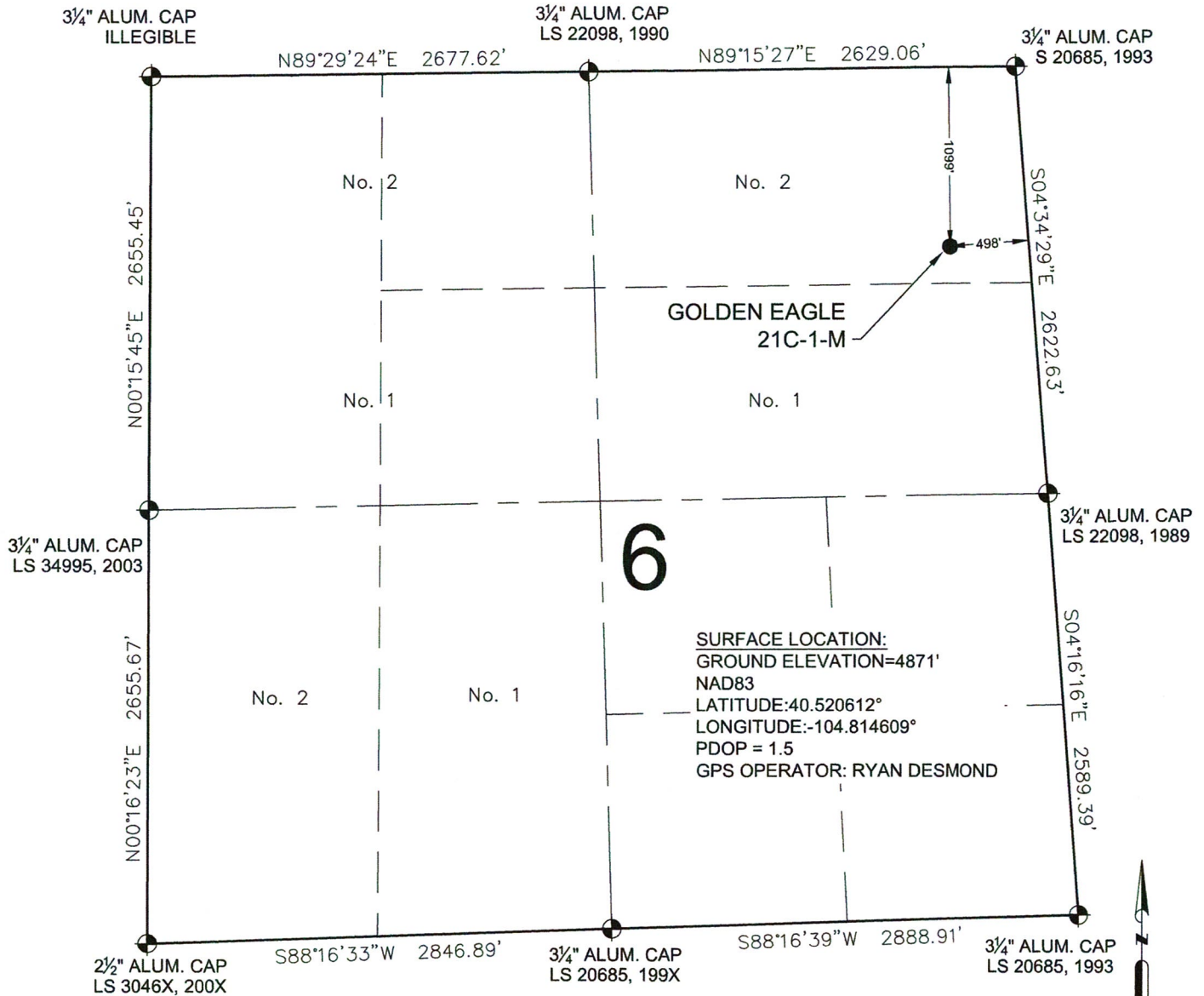


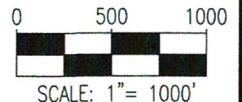
# GOLDEN EAGLE 21C-1-M WELL LOCATION EXHIBIT - AS-BUILT

## WELL GOLDEN EAGLE 21C-1-M LOCATED 1099' FNL & 498' FEL



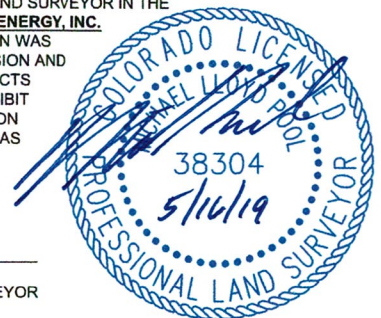
