Stained soil at wellhead (Great Western 27-51) COMPLY WITH RULE 907.E. (Corrective Action Date: May 13, 2019) See attached photo #5. 2. Inadequate berm surrounding tank battery. According to COGCC maps, location is in flood plains. COMPLY WITH RULE 603.H.(2).C. (Corrective Action Date: November 3, 2019) See attached photo #11. 3. Tanks/separator not anchored. According to COGCC maps, location is in flood plains. COMPLY WITH RULE 603.H.(1).C. (Corrective Action Date: November 3, 2019) See attached photo #12, 13. 4. No NFPA placard/BBLs faded (not legible) on produced water tank. INSTALL SIGN TO COMPLY WITH RULE 210.D.
