INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A hot oiler was heating the tank when a possible air bubble in the line caused condensate to burp out of the top. A total of approximately 5 barrels was spilled inside and outside of containment. A vacuum truck arrived on location to pull the water pit right after the incident, so the lease operator was able to get him to vacuum up the standing product immediately. Cleanup continued until all impacted or potentially impacted soils were removed via hydrovac.
