Operator Comment: The noxious weeds on the slope have been cut, bagged and disposed of properly. The area has been seeded. The area will continue to be monitored and if it needs reseeded in the spring of 2020 it will be seeded again. Note: consulted a reclamation specialist that is reclaiming the mine located on VPR. He has advised me that it can take 2 to 3 years to reestablish vegetation on those slopes in that soil. They have been reclaiming that mine for 20 plus years.

COGCC Decision: Approved pending re-inspection

COGCC Representative: Photos do not clearly show weed treatment. There were perennial and biennial noxious weeds growing in the area which will need to be treated early in the next growing season. Fall herbicide treatment can be effective while plants are still green, which is recommended in the Wapiti Weed Plan.
Note: Cut slopes must be stabilized to prevent erosion. Signs of erosion identified by inspection showed seed likely washed away. The seeded area must be stabilized until vegetation establishes. Vegetation establishment does not take 2-3 years if performed correctly.

Operator Comment: The culverts are cleaned out and the area at the end of the culvert will have rock installed. That is a natural raven that is at the end of that culvert and doing more than adding rock would do more damage than good.

COGCC Decision: **Not Approved**

COGCC Representative: Note: Cut slopes must be stabilized to prevent erosion. Signs of erosion identified by inspection showed seed likely washed away. The seeded area must be stabilized until vegetation establishes.
Culvert outlet protection is required to prevent erosion. All disturbed areas including area at the end of the culvert must be seeded and stabilized.
Corrective action does not appear to have been performed.

OPERATOR COMMENT AND SUBMITTAL

Comment: The weeds have been removed from this location. The area is turning a little green from the seed that was planted, however it has been freezing at night in this area. We will monitor the growth come the spring of 2020 and reseed if needed. Herbicides will be applied in the spring to control weed growth per the weed plan.
