Comment: After the inspection report was submitted, our Routt County foreman was notified of the corrective actions required. After tightening valves and fittings at the wellhead, he removed the oily rag and took pictures of the cleaned up wellhead and pumping unit. Foreman/pumper has been notified to check these fittings on a weekly basis to ensure integrity. Pictures have been attached to this FIRR.  
Since the saddle bearing of the unit is completely worn, we've just recently worked a deal with a nearby operator to purchase one of their pumping units to replace the one at the Baeirl. This unit is much more robust and should allow us to continue running the well without risk of a mechanical failure at the pumping unit and/or wellhead.  
The pit on location does have a facility ID in the COGCC system. As we have plans to test this well's productivity in other zones within the next year, we will keep the pit active in case we need it during the test. Should the test come back unfavorably, we will start making arrangements to close the pit via Form 27.
