 On 10-15-2019, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to noise/odor. The complainant Andrea Chavez 4743 Raven run Broomfield CO stated the issues were occurring outside of complainants home. On 10-17-2019, I attempted to make contact with the complainant who stated that on 10-06-19 and 10-12-19 inside complainants home. On 10-12-19, No windows were open as they were watching TV there was a very low active constant buzzing noise that was coming from the rig. ON 10-01-19 Burning chemicals, not quite a tire-very dirty smelling. I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not hear any unusual noise or odors in or around location. I have attached sound study for the night in question. It appears location noise is within the rule limits.  
 At time of inspection, I spoke with Danny Herrera drilling supervisor he stated at time of noise complaint they were pulling and running casing.
