CAUSE INFORMATION: Improper alignment of a valve mechanism in a valve can caused the produced water to overflow ~1500 barrels to ground across ground to an unnamed irrigation channel in proximity to Roan Creek (an irrigation ditch) which eventually flows to the Colorado River. Perhaps 750 barrels of the produced water reached the creek. The rest soaked into the ground. The produced water had been carried via pipeline from a storage pond to this valve can. The caller just called again to report that it is not thought that the produced water made it as far as the Colorado River in this unnamed irrigation channel. They want to be sure we are clear that the water did NOT reach Roan Creek. This release was in Garfield

County, about 80 ft. from Mesa County.
