Comment Site has been heavily grazed. Well established grasses are holding up to grazing pressure; but care should be taken and monitoring of vegetation conducted during grazing season. There are a few noxious weeds, Houndstongue, Thistle as well as ruderal weed Curly dock on site. Rancher is siting salt blocks on location, intensifying animal impact. Recommended to remove Salt blocks from Location to discourage use of site as loafing area.
