A 1.90" 2.75# J-55 parasite string was set with the mandrel at 2,449'.

TPZ is estimated at the TOG estimate of 8229' as the well has not yet been completed. The estimated completion date for the well is prior to 12/15/2019. The actual TPZ footages will be provided on the Form 5A comments after the well is completed.
