Engineer	Offset water well check: COGCC evaluated offset water wells within one mile of this proposed well's surface hole location. The deepest water well within one mile is 175 feet. Offset Well Evaluation: Existing offset oil and gas wells within 1,500 feet of the wellbores on this pad meet standards.
