Fill dirt was hauled in to replace the impacted soil removed from the location, then all four walls of each pit were pushed in and topped with 4 loads of topsoil. The area was then cross ripped to alleviate any compaction, final graded, and prepared for reclamation activities. The entire disturbed area was tilled, planted with a grass seed mix matching the native grass area, and then finally a straw mulch was crimped in for soil stabilization.
