This is a follow up inspection per Doc. # 699300210</p> <p>During this inspection the following possible compliance issues appear to have been addressed:</p> <p>Housekeeping: Weeds growing around unused equipment stored on location. see photos #8, 9 and 10.</p> <p>Rule 907.e Housekeeping: Stained soil around WH appears to have been removed. see photo #3</p> <p>Rule 605.d Mechanical Issue Possible leak in separator housing appears to be fixed.</p> <p>Safety issue: pulley belts on PU and electric motor appear to have had guards installed. see photos #4 and 5.</p> <p>During this inspection the following possible compliance issue appears to have not been addressed: 1002..(2).D Conduct maintenance on equipment, cleanup stained material and review self inspection processes: Stained soil inside separator housing, in the previous inspection I inserted the wrong Rule for this issue.
