To Whom it May Concern:

Kerr-McGee Oil & Gas Onshore LP ("KMG") plans to drill the listed oil and gas wells from the above described surface locations.

Rule 318A of the Colorado Oil and Gas Conservation Commission's ("COGCC") Rules and Regulations requires that the wells be drilled in a square with sides four hundred (400) feet in length, the center of which is the center of any quarter/quarter, or a square with sides eight hundred (800) feet in length, the center of which is the center of any quarter section. Rule 318A also requires any new well to be located 50' or less from any existing oil and gas well. KMG plans to drill the wells at the above described location, and are requesting a waiver of those COGCC rules in order for the wells to be located more than 50' from the existing well and outside the legal drilling window. Please understand that the names of the proposed wells may be altered, but any such change shall not impact the validity or effect of this waiver.

If the above-referenced well locations meet with your approval, please so indicate by signing below, thereby waiving the two COGCC well-location rules described above. By executing this letter, you also acknowledge that KMG is authorized to submit COGCC Forms 2 and 2A for the location and wells cited above. Should you have any questions, please contact our office.
